BENEFITS

All Cherokee Tribal members may be eligible to participate in the programs and services operating within the Cherokee Nation. Each applicant must qualify for each program by meeting the established regulations and guidelines. For most programs and services, one must reside within the Cherokee Nation jurisdiction (which encompasses the 14 NE counties of OK) and fall within certain levels of income, family size, residence, blood degree, etc.

Most programs and services offered by the Cherokee Nation, Bureau of Indian Affairs, and Indian Health Services, require a CERTIFICATE OF DEGREE OF INDIAN BLOOD and/or TRIBAL MEMBERSHIP. Each Cherokee individual should have both in order to meet the certification requirements for each program, service, or agency. For information regarding the following programs, contact:
